Dear Mark.

Many thanks for getting in touch. As part of the Local Plan preparation, and subject to how the Council decide to proceed the Local Plan, the Inspectors request is for a heritage assessment of the Star Fields and as such this would be covered by the Local Plan budget. The heritage assessment would concentrate on the site being considered and any heritage implications of development.

A conservation area appraisal is much more detailed and would consider the entire conservation area as well as the surrounding areas to it, considering a number of factors. At this stage the resources and finances are not available for this to be undertaken, although the Council are aware that a programme of conservation area appraisals across the District, needs to be done when possible. As such, TDC would not be able to fund this.

If the Parish were minded they could speak to Limpsfield, who are funding their own conservation area management process and have recruited specialist consultants to undertake this work. We have been able to assist Limpsfield by considering the bids tendered to them for the work and are providing comments and support to them on draft documents etc.
